- Enforced the Uniformed Code of Military Justice and state vehicle and penal codes by issuing citations and apprehending military members for such violations as unlawful entry, drunk and disorderly conduct, and assault.

- Served as dispatcher and handled complaint and emergency calls professionally. An example of a typical emergency call was from a mother whose baby was not breathing. After summoning emergency aid, I talked her through successful infant CPR that freed the object on which the child was choking and restored respiration.
- Participated in DARE anti-drug programs by acting as McGruff, the crime dog, and making presentations at schools about the importance of staying off drugs.
- While serving in Germany, assisted local police with intervention in disputes between American personnel and local nationals; participated with them in investigating accidents and other incidents involving American military personnel.
- Served for two years as a community police officer aboard a military installation. Responded to calls on neighborhood disputes and domestic disturbances, apprehended suspects; conducted field interviews; enforced state and post regulations; and served as a crossing guard.
- Served as shift supervisor and team leader of up to 12 people. Conducted personnel equipment and uniform inspections prior to the start of shifts; led training exercises; evaluated performance. Conducted training on fundamentals of marksmanship and zeroing on the M-16 rifle and the Beretta 9mm pistol.
